Stealing in Dwellings, from the Person, &c.

On 25th ult., from the person of Thomas Evans, while asleep at Wandering,—black morocco pocket book containing cheque for £2, drawn by John Brown, Chairman of Wandering Roads Board, in favor of Samuel Dowsett or bearer, dated 24th August, 1877; No. either 20 or 21, drawn on the W.A. Bank; promissory note drawn by R. Glover, Wanneroo, in favor of Thomas Evans, dated in November 1873, and a portrait of a female and child. Alexander Bailey, Exp., Henry Brennan, Exp., and Charles Dixon, free, suspected.—C.I. 301.
