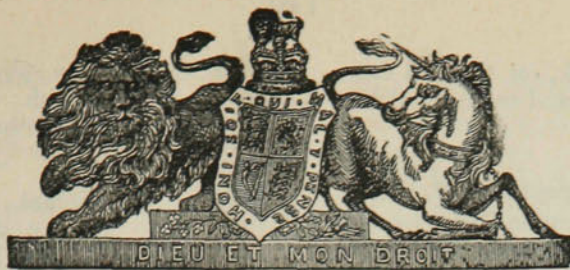

MURDER.

Two skeletons have been recently found at Maryvale, Edenhope. They are believed to be those of Maria Cook and daughter. Maria Cook was married to Robert Cook on the 14th March, 1874. In about three days after, her husband, herself, and child (illegitimate) left with the professed intention of taking up land about Horsham. There is little doubt now but the remains found are those of Mrs. Cook and child, and that they have been murdered. The most searching inquiry is now requested to be made regarding Robert Cook. Description:—English, laborer, about 5ft. 6in. high, slight build, about 9 stone weight, very dark complexion, black beard, whiskers and moustache, all of which he kept trimmed and did not allow to grow very long. He had his thigh broken some years prior to his marriage, and used to draw his leg as if it were stiff at the knee. He was fond of talking, and talked loud when in company. At the time he left he had a double-barrelled gun, and a water spaniel dog with him. Henry Davis, a shipmate of Cook, saw him about two years ago, at Millicent; Cook was then 32 years of age, about 5ft. 6in. high, thick set, dark complexion, black hair, bushy beard and whiskers, medium nose and mouth. Was then with Walhalla Bros., American circus, as a knock-about hand; he arrived in Adelaide in the ship "Electric" in 1865. A man named Barrington, a stationer at Nhill, was with the circus at the time named. Barrington was known as Montague. Cook is said to have a noticeable mark or cut over one of his eyes.—O. 4481. 22nd July, 1884.

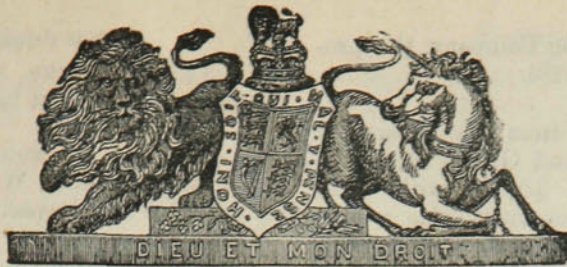

Further particulars.—Robert Cook is a native of Holbeach, near Gedney, Lincolnshire, England. He arrived in Adelaide about the year 1865 or 1866. Has generally worked on stations about Mount Gambier, the Darling, Swan Hill, and Nhill. Was employed about the year 1870 on Tintandra Station, about 10 or 12 miles from Swan Hill, the then owner being a Mr. Beveridge. Cook has two brothers, John and Thomas, living at Jung Jung. His mother lives at Tarennyenny, near Nhill, and three other brothers, named Frederick, Samuel, and William, are selectors at Nhill. He is further described as about 36 years of age, about 5ft. 4 or 5in. high, medium build, dark sallow complexion, black straight hair, dark brown eyes, medium nose, inclined to be thick at the point, rather small round features, full black beard, whiskers and moustache, which may be shaved off, supposed to have a scar mark over one eye, had his thigh-bone broken when a boy, causing

him to walk rather stiff, but not exactly lame. He cannot write, and it is very doubtful if he can read. Generally had a double barrelled gun and a dog, and was very fond of shooting.—O. 4481. 30th July, 1884.
