ESCAPED PRISONER.

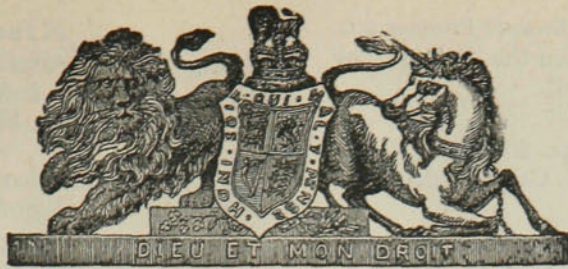
Portrait of offender at Detective Office, Perth.
