## Murder.

*Georgia, United States of America.*—J. G. HOPKINS is wanted, charged with the murder of R. K. EVANS, in the County of Thomas, Ga., State of Georgia, United States of America, on the 1st November, 1898. Description: A physician by profession, 49 years of age (looks younger), 5ft. 8in. high, slight build, about 9 stone weight, sallow complexion, deep-set greyish blue eyes, dark sandy hair and moustache, large, straight, sharp nose, sharp features, shoulders slightly sloping, erect carriage, hands long and flexible, middle finger of right hand missing, four or more upper front teeth artificial ; in talking, nervous clearing of the throat, slight twitching of the muscles of the mouth, lifting chin as if stretching neck, and teeth held together ; small long wart on throat ; writes a rather poor scratchy hand.

A reward of 1,500 dols. is offered for the apprehension of this offender.

Special inquiry is requested for the whereabouts of JOSEPH GOENCZI, who is wanted on warrant issued at Berlin, Germany, on 25th August, 1897, for the murder of Auguste and Clara Schultze.

Description: A native of Maros-Varsahely, in Transylvania, an Austrian citizen, a Calvinist; speaks German, Hungarian, Roumanian, and Polish; short and stout build, height about 5ft. 5in., age 47 years, dark curly hair mixed with grey (formerly dyed almost black), low forehead, rather thin dark-brown eyebrows, broad nose, small brown eyes, proportionate mouth, lips a little turned up, yellowish complexion, fair to dark moustache, and beard parted in the middle and usually dyed black, upper part of cheeks shaved; very easy manners; big scars extending from the right side of the neck to behind the middle of the ear, described by the Austrian military penitentiary reports as scrofulous scars, but which Goenczi stated are the result of a shot wound; birth-mark as large as a pea on the right shoulder-blade.

He was accompanied by his wife, Anna Goenczi, *nee* Sattler. Description: A native of Bavaria, a Roman Catholic; short and stout build, about 5ft. 5in., age 50 years, dark hair worn plainly parted,

sometimes waved in front, dark brown eyebrows, narrow visage, yellowish complexion, dark brown eyes, round chin, defective teeth; has a goitrous tumour on the right side of neck.

They left Berlin on 18th August, 1897, for Frankfort-on-Oder; and on the 19th they went *via* Cottbus to Halle. Their luggage was booked to Brussels, and was taken away from that city on the 25th August, 1897. Since that date all trace of them has been lost. When they left Berlin they were accompanied by a white and yellow sprinkled wolf-dog called "Butzi." Goenczi is a shoemaker by trade, a skilled cutter and preparer, but is described in his military papers as a sailor.

A reward of 1,000 marks is offered by the Royal Police President, Berlin, for the arrest of Goenczi.

If traced in this Colony, information must be forwarded to the Criminal Investigation Branch, Perth, before any steps are taken to effect his arrest.
