Circular Orders and Miscellaneous Information.

C.O. $\frac{33}{3}$.—Members of the Police force stationed in the vicinity of the Northern Stock Routes are required to do all they can to protect the wells and water supply appliances from damage, and to prosecute any person who may be discovered to have done any such damage.

It is reported that in some recent instances such property has been injured.

C.O. $\frac{34}{3}$.—It is notified, for the information of the police, that the medical officer of each hospital who is in receipt from the Government of a Subsidy-in-Aid of £100 per annum, is required to visit prisoners in gaol or under remand, when in custody, if called upon to do so; and to attend professionally, at his residence or at the hospital, such civil servants of the Government as are entitled to medical advice. If, however, the medical officer is required to visit them at their homes, he will be entitled to charge a fee of five shillings.

Members of the police force requiring to call in medical attendance for a prisoner, or to consult a physician themselves, must adhere strictly to the instructions contained in the standing Regulations. Any member of the force incurring expense through neglecting to obey this instruction will be surcharged with the amount involved.
