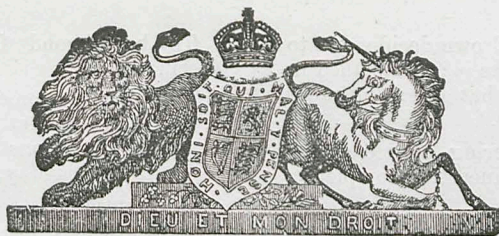

## Circular Orders and Miscellaneous Information.

### CRIMINAL STATISTICS.

C.O. <sup>11</sup>/<sub>1904</sub>.—Officers in charge of Districts will forward to the Detective Office, Perth, as soon as possible after the 31st of December in each year, a return showing the total number of offences dealt with by the Police at each Station in their District during the preceding 12 months. This return must include all offences reported to or by the Police, and all cases dealt with by the Police. Form P. 44 will be used for this return; the total number of offences reported being shown in the first column, and those found, on inquiry, to be doubtful or fictitious, in the adjoining one.

To assist in compiling the information, a book, ruled in the form below, will be kept at each Station.

A return will also be sent in at the same time of all licenses issued during the year under the Wine, Beer, and Spirit Sale Act, distinguishing between each class of license, and showing whether they are renewals or new licenses.

A list of Employment Brokers' Licenses, Pawnbrokers' Licenses, and Gold Buyers' Licenses is also required.

The attention of N.C. officers and constables in charge of stations is also directed to the following additional instructions to those contained in printed circular:—

“Criminal Charge Returns, etc., dated 22nd November, 1902” :—

Form B, “Weekly Return of Prisoners Discharged,” must be forwarded regularly to the Government Statistician, Perth; where no prisoners are discharged a “nil” return must be sent in.

Greater care must be exercised in compiling the Criminal Charge Cards (Form A). The information required must be given as accurately and fully as possible.

A separate card must be used for each offence.

In cases where a person is charged on summons, the date on which the summons is returnable must be given under the “date of arrest.”

When a prisoner is removed from one station to another on remand, the charge card must be forwarded with him, and must be numbered and completed at the station where he is tried.

Remands of deserters to the military or naval authorities must be considered as the final disposal of the case and entered on the card accordingly. Remands to the other States will be treated in a similar manner.

When a prisoner is dealt with as a first offender the sentence must be shown under one of the following heads:—

- (1.) Discharged as a first offender.
- (2.) Discharged as a first offender on payment of damages and costs.
- (3.) Convicted (give sentence) and discharged as a first offender.
- (4.) Convicted (give sentence) and discharged as a first offender on payment of damages and costs.

If a fine is inflicted, the amount must be stated; and if there is an alternative, the card must always show whether the fine was paid, or the offender served the term of imprisonment.

In cases of assault with intent, etc., the nature of the intent must be stated.

In disobeying an Order of Court, the nature of the order must be given.

When a charge is reduced, the offence must be altered on the card accordingly.

When a prisoner is committed for trial or sentence, the place and date where the Sessions are to be held should be given.

The return of Circuit Courts or Courts of Quarter Sessions must invariably be forwarded as soon as possible after the sitting of the Court. Care must be taken not to omit cases where a *nolle prosequi* is



entered, and in cases where the Crown decides not to prosecute, and the prisoner's name is not included in the Calendar, a notification to that effect must be forwarded to the Detective Office.

In forwarding Form E (covering charge cards) the number of each card retained for completion should be given.

Where no charges are taken during the month, a *nil*. Form E is alone required, and charge cards are not required.

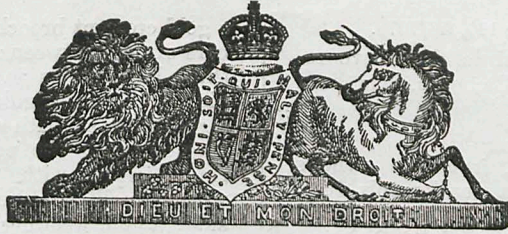

COMMONWEALTH IMMIGRATION RESTRICTION ACT.  
(1 Edw. VII., No. 17, Section 8.)

C.O.  $\frac{13}{1904}$ .—The attention of the Police is directed to C.O.  $\frac{50}{1903}$  of the 23rd December, 1903.

When reporting to the Customs Authorities the imprisonment and date of release of Persons, not British subjects by birth or naturalisation, who have been convicted of any crime of violence against the person, the following information, where it is procurable, shall be supplied, in addition to the ordinary particulars of the crime for which the sentence is being served :—

- (a.) Length of residence in the Commonwealth.
- (b.) Whether the offence was the first or not.
- (c.) Whether the man is coloured.
- (d.) Whether he is married, and, if so, whether his wife and family are in Australia.
- (e.) Police report on the man's character generally.

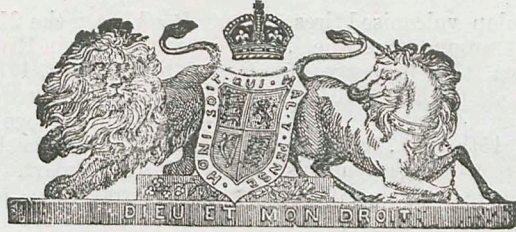
