SLY-GROG SELLING.

The following copy of a minute bearing on the employment of informers in sly-grog selling cases is published for general information:—

C.O. 3413/07.—The Police should note that Section 630 of the Criminal Code is repealed by the Evidence Act of last year, and that accomplices no longer require to be corroborated as a matter of law, although judges will advise juries not to act on the uncorroborated evidence of accomplices, as was the practice before the Criminal Code was passed.

Further, *Moore v. Carroll* decides that an informer acting with a view to obtain evidence in order to convict a man is not an accomplice within the meaning of Section 630 of the Code, even if it were still in force, and the evidence of such a person at no time required, nor does it now require, corroboration as a matter of law, although no doubt juries and magistrates would take into account, before acting on his evidence, that he is an interested witness in respect to the reward.

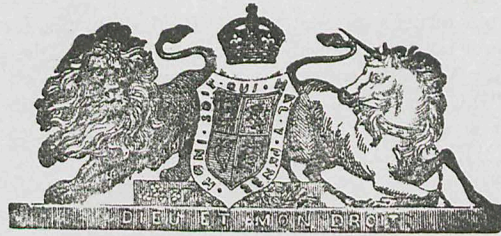

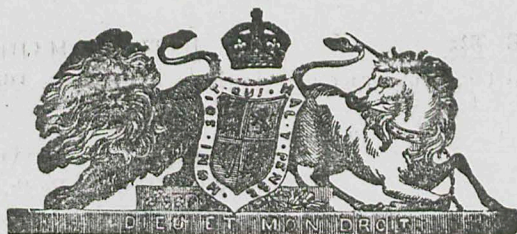
