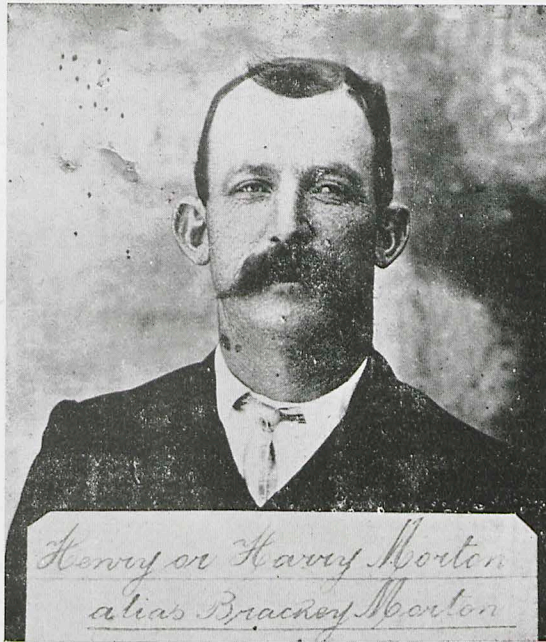

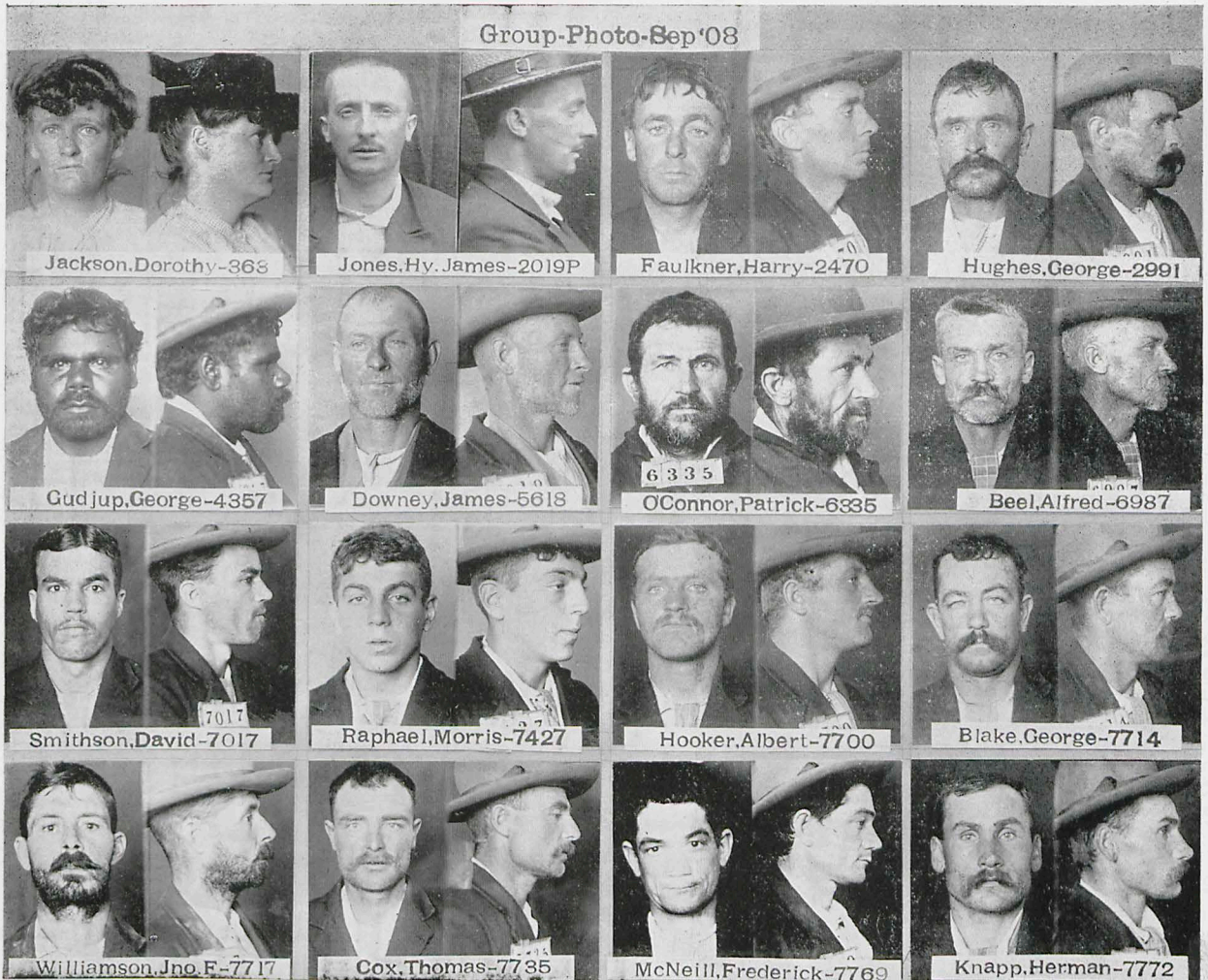


HENRY MORTON.

C.O. 23/1908.—The attention of District Officers, and the Police generally, is drawn to C.O. 5/07, relating to the Finger Print system, as it is evident that the directions contained therein are being, in many cases, disregarded.

Particular attention is drawn to that portion of the C.O. referring to the detection of crime, and Officers in charge of districts are directed to bring to the notice of the Commissioner every case in which a member of the Force, when investigating a crime, succeeds in finding the finger prints of an offender.

Cases have recently occurred in which old offenders have been received into prison, who have been dealt with by Magistrates as men with no previous convictions, whereas if their finger prints had been taken and forwarded to the Criminal Investigation Branch, they would have been at once identified as persons who had already undergone terms of imprisonment. Greater care must be exercised in this direction.

District Officers are expected to take an interest in the system, and, when inspecting Stations, see that the instructions issued regarding the taking of finger prints, and the use and care of the materials supplied, are strictly carried out. The system is one which places a powerful weapon in the hands of the police, and it is essential that greater use should be made of it.

All members of the Force arriving in Perth, on duty, must, in future, report themselves at the Criminal Investigation Branch for further instruction.
