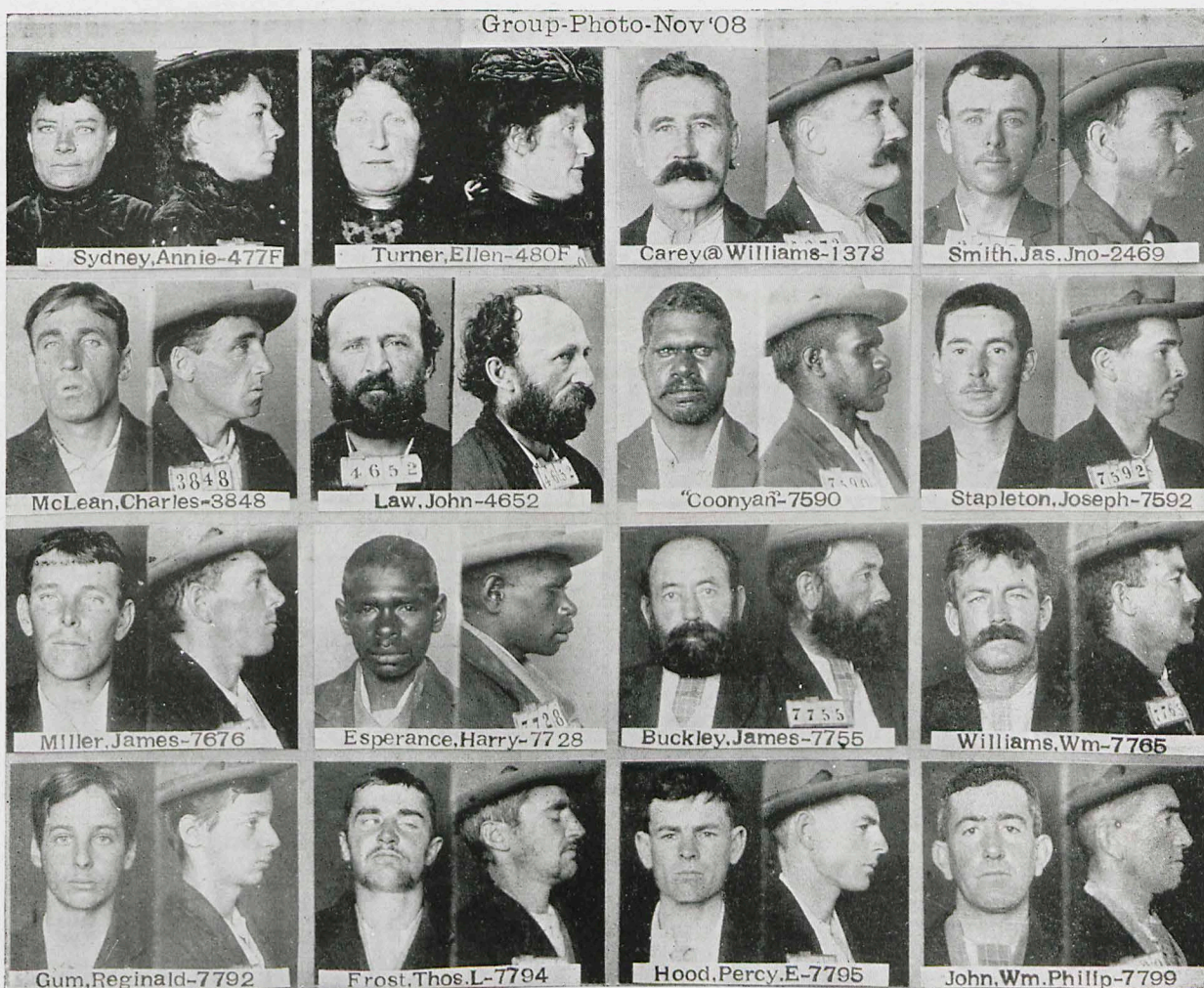

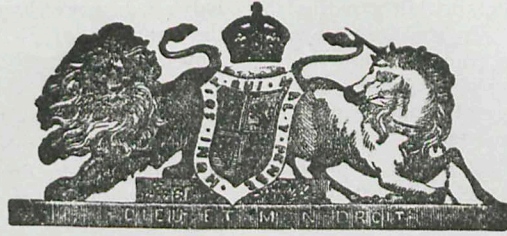

C.O. 29/1908.—The following revised scale of Police Travelling Allowances, approved by His Excellency the Governor in Council on the 15th October, 1908, will take effect from the 1st instant, in lieu of scale dated 6th March, 1903 (C.O. 8/1903):—

Goldfields allowance will apply to Stations eastward and inclusive of Southern Cross and Yalgoo.

2. Police employed on Gold escort duty on the main escort routes between Wiluna and Leonora, Peak Hill and Nannine, Sandstone and Magnet, Wiluna and Nannine, and Norseman and Coolgardie, 12s. per day.

3. No travelling allowance will be granted unless a member of the force is necessarily absent from his station on duty other than beat or regular duty for

not less than six hours, when the following maximum allowance will be granted:—

Officers	2s. 6d.
Sergeants and Detectives	2s.
Corporals and Constables	1s. 6d.

(25 per cent. extra on above rate allowed on Goldfields.)

4. Two-thirds of the above rates (Table A), may be claimed by Police necessarily absent from station on duty from 12 to 16 hours. The full rate per day will be allowed when necessarily absent 24 hours. One-fourth of the above rates may be claimed for every additional six hours over and above the 24. In all cases the duty must be continuous.

5. Plain-clothes constables attached to the C.I. Branch will be entitled to the same allowance as ordinary detectives.

6. Members of the force travelling on patrol or other duty in the Western, Roebourne, Kimberley, or other Districts, where means of free transport of provisions are provided by the Department, will not be entitled to travelling allowance if in receipt of ration allowance. This will not apply to District Officers and Constables accompanying them when travelling on duty in the districts named.

7. Police on temporary transfer or relief duty will be entitled to travelling allowance whilst *en route* to and from the station, and from a period not exceeding 10 days from date of arrival. The ordinary rate for the district, less 25 per cent., will then be allowed for a further 11 days, after which the usual lodging and district allowances only will be granted in the case of single men. Married men, however, will be entitled to draw the subsistence allowance, less 25 per cent., for the remainder of the period temporarily absent from their station. One-fourth of the subsistence rates specified in this clause will be deducted in cases where police sleeping accommodation is provided.

8. The preceding clause will not apply to members of the force detailed for temporary transfer or relief duty at suburban stations in the Metropolitan, Fre-

mantle, and East Coolgardie Districts within a radius of six miles of the head station. In such cases an allowance of 1s. per meal will be granted where the District Officer is satisfied that such expense was necessarily incurred. No travelling allowance can be claimed by police proceeding from station to station on duty within the six miles radius in the districts mentioned above unless for a full day's absence from their station.

Travelling beyond State limits.

9. Police travelling on duty outside the State will be entitled to the following allowance:—

At sea—Officers 4s. 6d. per day; other grades, 2s. 6d. per day.

On shore—25 per cent. in addition to the ordinary rate of travelling allowance for the coastal districts of the State.

No allowance can be claimed otherwise by the police travelling by sea.

10. Police attending courts, or employed on surveillance or other duty apart from beat or regular duty continuously for five hours and unable to return for meals to their usual place of residence, may claim the following allowance:—

Officers—2s. per meal.

Sergeants and Detectives—1s. 6d. per meal.

Other grades—1s. per meal.

Claims for this allowance must be rendered on Form 10, and the officer certifying must satisfy himself that the expense was necessarily incurred.

11. Refreshment allowance at above rates, plus 25 per cent., will be granted to Police employed on duty at races, sports meetings, and similar gatherings. No travelling allowance will be granted in connection with racecourse, or other such duty, for a less journey than 6 miles by road or 12 miles by train (one way), or unless the officer is detained for eight hours at least on such duty.

In special cases not provided for in the preceding clauses, the Commissioner of Police will investigate and deal with claims for travelling allowances.

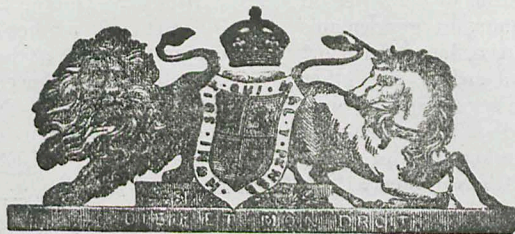
