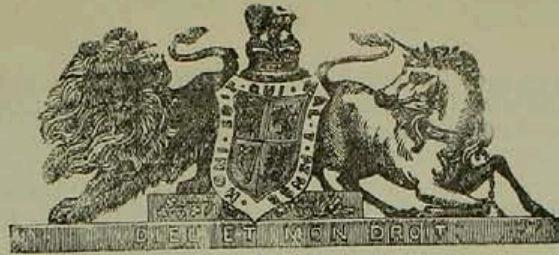

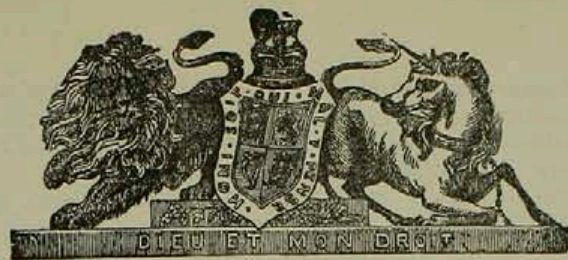

## Circular Orders and Miscellaneous Information.

C.O. <sup>6</sup>/<sub>1004</sub>.—From the 26th instant, the following Rule will be observed by Members of the Police Force travelling or procuring transport for Prisoners and others, on Government Railway Lines throughout the Colony:—

Instead of the present system of paying for Rail-tickets, and rendering monthly accounts, "Railway Ticket Orders" will be exchanged at the Booking Offices for tickets, and monthly returns furnished to this office of all ticket orders issued.

Each Station will be supplied with "Railway Ticket Order" Books, and printed return forms.

Officers will be careful in each case to have the order filled in properly, and the particulars noted on the counterfoil, which is to be retained.

Transport of Police and their families is payable by the "Police" Department; of prisoners, including discharged Native prisoners, by "Gaols" Department; of Lunatics, by "Medical" Department; of destitute persons, except aborigines, by "Charitable Institution" Department; of destitute aborigines, by "Aborigines Protection Board."

These instructions apply to passenger transport only. Transport of stores, effects, &c., will be provided for by requisition as at present.

The present system remains in force on all Railways other than the Government lines.

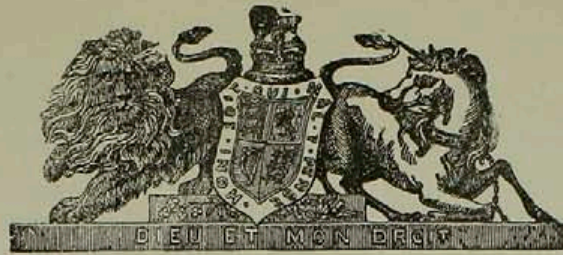
