Rules and Regulations for the guidance of the Detective Police in the performance of their duties.

THE Detective Police are subject to the same discipline as other members of the force, but their attention is principally directed to the detection of crime and to a special surveillance of the criminal classes.

2. The detectives will be selected from the ordinary police, or from among candidates offering themselves for this service, who, whether they have had previous police experience or not, are considered suitable for this service. They will first be employed on probation, after which, if they are reported favourably of by the officer in charge of detectives, they will be appointed as third-class detectives, and be promoted to the rank and pay of second or of first-class detectives as vacancies occur, and as they show by their zeal and efficiency their fitness for such advancement. Promotion to the rank of officer is obtained on the same conditions as in the preventive force: the rank of first-class detective is equivalent to that of first-class sergeant, second-class detective to that of second-class sergeant, and third-class detective to that of constable.

3. The distinction between the detectives and the general police is sufficiently explained by the terms "preventive" and "detective," but these terms are to be understood as only indicating in a general way the nature of the duties the two branches of the service are called upon to perform. It is neither practicable nor desirable so to divide police duties that the prevention of crime shall be left to the one branch, and the detection of crime already committed to the other; the preventive police must necessarily be employed in detective inquiries and investigation, while the detectives will sometimes be employed on general police duties.

4. In the performance of detective police duty the exercise of reticence and tact will generally be sufficient to enable any member of the force to cope with the machinations of criminals. It should be the object of a detective to avoid everything that tends to excite distrust and suspicion or expose him to misrepresentation. If he conducts himself so as

to lead to a suspicion that he is untruthful, there will be little confidence in his integrity and good faith, and his usefulness will, in consequence, be materially impaired.

5. All detectives communicate direct with the officer in charge of detectives in Perth, where a certain number are retained under his immediate orders; the remainder are stationed in towns under the command of the officer in charge. At stations where there is an officer in charge, detectives report themselves to him daily at an appointed hour, when they submit to him all official letters and communications which they receive, and their replies thereto. They also furnish him with information of all matters of duty which come under their notice or require their attention, and acquaint him with the steps they have taken or intend to take in the particular cases they have in hand, and will obey any instructions he may issue to them. When, however, a detective receives from an officer any order which clashes with the instructions he has received from the officer in charge of detectives in Perth, he must acquaint the former with the same, and, if the officer persist, the detective must of course obey him, but will immediately report the circumstances to the officer in charge of detectives in Perth, who, if necessary, will submit the matter for the decision of the Commissioner.

6. When a detective is doing duty at a station where there is no officer, the nature and extent of his communications to the police at the station must to a great extent be left to his own judgment and discretion; but he will be held strictly responsible that the public interest does not suffer through undue reticence on his part. He must conduct his business in such a manner as not to clash with the action of the general police. He will keep the member of the force in charge advised of his absence from and return to the station, and, as far as may be expedient, of the duties on which he is engaged. There will, however, occasionally occur cases in which entire secrecy is desirable.

7. With a view to the detection of crime in their respective districts, the detectives must endeavour to acquire a knowledge of the members of the criminal class; must watch their movements, and promptly

communicate particulars of the same and of other necessary information to police stations. They are required to furnish periodically to the officer in charge of detectives surveillance returns of all suspected persons in their respective districts or divisions.

8. Detectives will be afforded opportunities of seeing prisoners with a view of recognising them, studying their features, and otherwise familiarising themselves with the personal appearance, habits, and character of the criminal class.

9. In reporting the particulars of inquiries conducted and arrests made, and generally of the steps they have taken, the detectives must not omit to include the names of other members of the force who have been engaged with them in the same duties.

10. When an officer of police is present at a court of petty sessions, the detectives must hand their briefs of evidence to him, and otherwise afford him every assistance to enable him to conduct their cases, or to make other arrangements for the same.

11. Detectives are not to withhold from their officer any information they may be possessed of relating to their duty.

12. As it is obviously necessary that they should perform their duty in private clothes, each detective is furnished with a badge of office, entitled "Certificate of Authority," to carry on his person, and to produce when necessary.

13. The certificates are on no account to be transferred from one detective to another, nor will they be issued a second time. They are numbered consecutively as issued, and on any member of the detective police leaving that branch of the force his certificate is cancelled. Each member of the force will be strictly responsible for the care of the certificate issued to him, and upon no account is he to let it go out of his possession.

14. Any detective who through neglect or carelessness loses his certificate will be severely punished. He must immediately report the loss to his officer, and, unless he can give a satisfactory explanation as to the cause of the loss, he will at once be suspended from duty until the charge against him of neglect has been disposed of.

15. These certificates are the property of the Government, and must be returned, with other appointments, by members leaving the force. In the event of the death of any detective, care must be taken to secure his certificate and transmit it to the Commissioner without delay.

16. Certificates are only issued to members of the detective force who are on the permanent staff. To those on probation, or persons employed on occasional duty, a memorandum will be given by the officer in charge of detectives; this must be given up on the discharge of the holder, or when he is appointed to the permanent staff.

17. The certificate is the only badge used by detectives holding permanent appointments. In cases where, in addition to the certificate, proof may be required that the bearer is the person named therein, the detective can produce his memo. book, some official letters, cards, or like documents.

18. In order that officers of police may be able the more readily to decide whether any documents of the kind that may be presented to them or to the police under their command, or which they may find in any person's possession, are genuine or not, one of the certificates in blank is filed for reference in the office of each officer in charge of a district.

19. It is requested that any instance in which any improper use has been made of the documents thus issued to members of the detective force may be at once reported to the Commissioner.

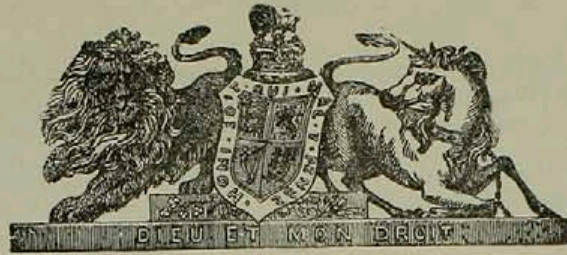

Circular Orders and Miscellaneous Information.

C.O. ^{6/1036}.—In forwarding information of property stolen, lost, or found, to Detective Office, the Police will see that every article is minutely described for the purpose of identification.

In describing jewellery and watches, it should be stated if gold, silver, or metal; if the former, the fineness and weight; if the latter, the colour.

The condition of each article should be shown, *i.e.*, if new, worn, or much worn.

WATCHES should be described, whether hunting, half-hunting, open-faced, or double-cased (the latter term being applied to watches whose outer case is removed in order to wind); if plain, ornamented, or engine-turned cases; Roman or plain figures on dial; centre or sunk seconds; gold or steel hands; enamelled or metal dial; stem or key-winding; English, American, or Swiss make, &c.; lever, horizontal, or duplex escapement; plain or balanced wheel; capped, jewelled, or $\frac{3}{4}$ -plate; maker's name, number, monogram, marks, or dents on cases, dials, or movements.

JEWELLERY.—If *chains*, the length and pattern. *Pendants and Locketts*.—Size and shape; plain or engraved; if seal pendant, shape and description of stone, and, if cut, the design. *Rings*.—Lady's or gentleman's; plain or engraved; if signet, the shape and description of shield or stone, and particulars of seal; if containing stones, their number, description, and setting. *Brooches, &c.*—Design and marks. If set with stones, their number, description, and setting.

BOATS.—The build, material, length, colour, marks, and fittings. *Oars*.—Length and material.

BOOTS.—Whether men's, women's, or children's; size, shape, material; plain, goloshed, or half-goloshed fronts, with or without toe-caps; broad, medium, or pointed toes; machine or hand-sewn, pegged, or rivetted; plain or nailed soles; heel or toe-plates; lace-up, elastic-side, blucher, &c.; and the nature of any repairs.

CLOTHING, &c.—Material; machine or hand-sewn, slop or tailor-made. *Coats*, if sac, frock, dress, tunic, &c., and marks or repairs.

HORSES AND CATTLE.—Sex, colour, condition, breed; brands and exact position of same. If *horse*, age, height, points, collar, saddle, or other marks, and if any white about face, body, or legs.

Constables, when taking reports as above, will refer to this notice, and apply for the information required. If the full description cannot be obtained, the C.I. or Memorandum, as the case may be, must be endorsed to that effect.

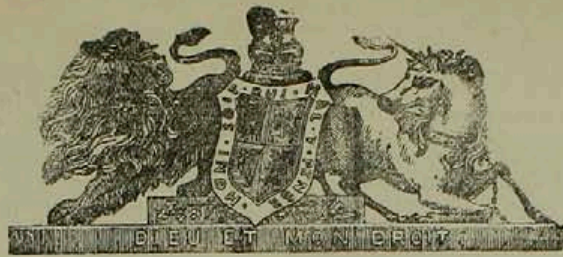
